



RETURN TO IN-PERSON WORSHIP!

The plan is, right now, is to have an outdoor sunrise service on the east side of the Well on Easter Sunday. This will be set up similar to how we had outdoor worship last fall. If you would like to participate in this worship service you will need to bring a lawn-chair or something to sit on, you will need to bring a mask for getting to and from your seating area. Easter Sunday is April 4th, the service will be at 7:00 AM. We will also have a service live streaming on the internet (Facebook and YouTube) on Easter Sunday at 11:00 AM, our usual time.

The following Sunday, April 11, we will have services in-person in the sanctuary. We will return to having two services, the contemporary service will be at 9:00 AM and the traditional service will be at 11:00 AM. We will have some restrictions when we come back.

Our Bishop has required all of the churches under his care, including ours, to adhere to CDC recommendations. We want to honor these requirements and do as the Bishop asks, and we also want to do the best we can as a church to show love to our neighbors by using the best practices we have available to us to keep others safe.

Here is what the CDC is currently recommending and what we will have to do when we return to in-person worship. Now, it is possible that these recommendations may change by April, and if they do we will adjust with them, but for now here is what we they are saying that we should do:

If you are FULLY vaccinated you may:

- Visit with other fully vaccinated people indoors without masks or social distancing.
- Visit with unvaccinated people from one other household without masks or social distancing.

You are considered FULLY vaccinated if it has been 2 weeks after you have received the second dose of the Moderna or Pfizer vaccines, or if it has been 2 weeks after you have received the single dose Johnson and Johnson vaccine.

However, EVEN IF YOU ARE FULLY VACCINATED, when you are in public with other people who may or may not be fully vaccinated (which includes corporate worship in our sanctuary), you must:

- Wear a well-fitted mask
- Stay at least 6 feet away from people you do not live with.
- Avoid large gatherings of people.

That means that for in-person worship, again this is until the CDC guidelines change, we will need to wear masks and social distance while we are in worship. The pews will have every other row marked off and you should make sure that you sit only with people that are part of your family unit. Masks will be required for in-person worship, and if you don't have a mask to wear we have some at the church that are available for you.
